### **TRADE EXHIBITOR REGULATIONS:**

The organiser does not accept any responsibility for any loss or damage from any cause whatever, in respect of any property brought to the festival premises by Exhibitors or their stand holders or their servants, agents, subcontractors or any other persons, and the Exhibitor or stand holder is required to indemnify the Organiser in respect of any such loss or damage to the exhibits or any other property brought to the premises whether it is their property or not. Without limitation the Exhibitor shall indemnify the Organiser in respect of any liability in respect of any damage to the site arising from use thereof by the Exhibitor, their servants or agents.

The Organiser shall not be liable to the Exhibitor for any pure economic loss, loss of profits, loss of business, loss of contracts, damage to property, depletion of goodwill or otherwise, in each case whether direct, indirect or consequential, or any claims for consequential compensation whatsoever (howsoever caused) which arise out of or in connection with the contract.

Upon arrival you will be shown your designated stand space by an Event Steward. Encroaching on another exhibitors space is strictly forbidden.

The decision of the Festival Organisers in any dispute is final.

All electricity requirements must be booked through the organisers. Sub-letting of electricity supply is not allowed and will lead to immediate disconnection. **THE USE OF PERSONAL GENERATORS IS STRICTLY PROHIBITED.** Due to the nature of supply, ie from generating sets, we cannot guarantee uninterrupted supply. If there is any disruption to supply we will endeavour to restore the supply as soon as possible. We will not be held liable for any loss suffered through matters beyond our control and will not accept any claims for loss of earnings or otherwise.

No booking will be accepted unless it is accompanied by the appropriate payment in full. Booking only for the duration of the festival, no single day bookings will be permitted.

Smoking is prohibited in all trade stands.

It is the responsibility of the Exhibitor to hold the necessary Public Liability Insurance cover for Third Party risks and to ensure all their staff work in accordance with the relevant Health & Safety Legislation.

There will be continuous night and daytime security patrols at and during the festival. Vehicles must be parked in the appropriate areas as instructed by Event Stewards. At the end of the Festival all Exhibitors must ensure that their stand is cleared and all rubbish removed.
